

TERMS AND CONDITIONS

Benefits apply only for guest(s) by covering the mandatory Resort Amenities Fee, while traveling with a reservation at a Vidanta Resort (hereafter the "Resort") through Resorts Condominiums International de México, S. de R.L. de C.V. (hereafter the "Exchange Company"), authorized Resort exchange company. Benefits are non-transferrable, non-cumulative with other benefit, promotion, discount and/or certificate; none of the benefits shall be redeemable for cash or other goods. All matters related to the subject matter of this services shall be governed by the applicable Mexican laws in Mexico territory, and the courts of Guadalajara, Jalisco, México; shall have exclusive jurisdiction over, and shall be the exclusive venue for all matter related hereto.

1. ROUND-TRIP LAND TRANSPORTATION SERVICE FROM THE AIRPORT – TO THE RESORT FOR THE GUEST(S) WITH AN INTERNATIONAL FLIGHT ARRIVAL¹:

Applies for guests staying at The Resort through the Exchange Company, traveling from a country outside of the Mexican Republic that comply with the following terms and conditions:

- Guest must present the international flight ticket used to travel from a country outside to the Mexican Republic, which must be under his/her name and coincides with the check-in date at the Resort.
- Free round-trip Airport – Resort – Airport transportation applies for the Guest and their companions that will stay at Guest's unit.
- The round-trip land transportation service is available by entering into the following website: "<https://shuttleservices.vidanta.com/>". Where guests must login to make a reservation. The guest accepts and understands the following terms and conditions:
 - Register the complete personal data of the guest and their companions in the system.
 - Register the complete data regarding the flight itinerary in the system.
 - Land transportation reservation must be booked 48 (forty-eight) hours prior to the flight departure schedule.
 - For those reservations in which there's an inconvenience during the scheduled arrival time, such as delayed flights, transportation service will be available up to 12 (twelve) hours after the scheduled pick up.

2. RESORT FEE CREDIT PROMOTION:

For a limited time, as a promotion and subject to change without notice, guest traveling with international flights, that present the international flight ticket used to travel from outside of México under his/her name, as well as coincide with the date of the check-in at the Resort, will receive a fixed amount of "Resort Credit" that will apply as specified below. The Resort Credit will be applied during check out at the front desk to the total bill. The Resort Credit may be used towards expenses accepted in the Resort Restaurants, Spa and Golf. Resort Credit will not apply to restaurants operated by third parties. Resort Credit, may not be redeemed for cash, transferred to a different account or reimbursed. Transferring any remainder does not apply. Resort Credit must be applied during the corresponding reservation and may not be applied in additional or future reservations.

For Nuevo Vallarta and Los Cabos:

The mandatory resort fee per hotel unit (HU), per stay is \$250.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$100.00 U.S. dollars.

The mandatory resort fee per one bedroom unit (1B), per stay is \$600.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$200.00 U.S. dollars.

The mandatory resort fee per two bedroom or any larger unit (2B), per stay is \$950.00 U.S. dollars, this fee includes a Resort Fee Credit credit promotion of \$250.00 U.S. dollars.

For Riviera Maya and Puerto Vallarta:

The mandatory resort fee per hotel unit (HU), per stay is \$200.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$100.00 U.S. dollars.

The mandatory resort fee per one bedroom unit (1B), per stay is \$450.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$200.00 U.S. dollars.

The mandatory resort fee per two bedroom or any larger unit (2B), per stay is \$700.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$250.00 U.S. dollars.

For Puerto Peñasco, Acapulco and Mazatlán:

The mandatory resort fee per hotel unit (HU), per stay is \$150.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$50.00 U.S. dollars.

The mandatory resort fee per one bedroom unit (1B), per stay is \$350.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$100.00 U.S. dollars.

The mandatory resort fee per two bedroom or any larger unit (2B), per stay is \$550.00 U.S. dollars, this fee includes a Resort Fee Credit promotion of \$200.00 U.S. dollars.

**Quantities are established in US dollars currency. Amount may be paid in Mexican pesos according to the exchange rate published by Banco Nacional de Mexico in the Diario Oficial de la Federación, the date when the resort fee exchange will be charged.*

3. WELCOME COCKTAIL:

One courtesy cocktail / beverage per person while being registered at the Resort. Non-alcoholic beverages will be available for minors.

4. GYM ACCESS:

The primary guest and their companion(s)(registered at the unit) may have access to the Gym facilities located at the Resort. Gym facilities vary upon the different Resort brands.

5. HOUSEKEEPING SERVICES:

Daily basic room housekeeping service during the stay.

6. INTERNAL RESORT TRANSPORTATION²:

The Internal transportation at the Resort consists in established short and schedules routes among the different areas at the Resort in special transportation vehicles.

7. VIDANTA GOLF COURSE TRANSPORTATION³:

The transportation service to the Vidanta Golf Course consists in round trip from the Resort to the Vidanta Golf Course and back from Vidanta Golf Course to the Resort through pre-established and scheduled routes.
